The Charter

Club PRIME is a friendly and constructive forum where events are organised for members (meetings, technical workshops, forums, etc.), where the subjects studied by ALLICE are formally defined and where the results of collective studies are reported and analysed. Each ALLICE member, represented by at least one member of the Club Prime, expresses their needs and expectations. The Club's modus operandi is conducive to the emergence of collaborative projects and encourages sharing dynamics. To function harmoniously, a few key principles are essential.

Club PRIME members will endeavour to:

PARTICIPATE

For sharing to take place in a spirit of trust and for cooperation to emerge, it is important that members know each other. Each member tries to participate as often as possible in the club's activities. If a member considers it appropriate for their company to be represented by several members in the Club Prime, they shall explicitly request this. These new members will be accepted, within a certain limit, after having validated the Club charter.

CONTRIBUTE

The benefits that all members will derive from ALLICE are closely linked to the involvement of each member. This Club is theirs: each member shares their experience, expresses their vision, suggests topics for collective studies or collaborative projects, ideas for new activities or points out events of interest to all members and for which a common presence would be relevant.

Members, when their organization allows it, occasionally host Club PRIME meetings in their premises.

During events organised by the Club, if the subject matter is not entirely within their field of competence, members are encouraged to be replaced or accompanied by another representative of their company who can make a relevant contribution to the discussions.

SELECT AND EVALUATE

Each year, at the request of ALLICE, the members select the topics for collective studies to be carried out and evaluate the work produced during the previous period. Each member is expected to participate in the decisions, according to the selection and evaluation procedures specified in the ALLICE rules of procedure.

BE CONSTRUCTIVE

Each member welcomes and listens positively to the ideas, experiences and questions of other members, experts, facilitators or any other interlocutor who participates in the exchanges.

RESPECT CONFIDENTIALITY

The more transparent the discussions, the richer the work conducted. For this reason, all members must be able, if they wish, to speak freely about their company, their needs and their challenges. Therefore, each member commits to respect the strict confidentiality of exchanges within the Club Prime. This also applies to ALLICE's team.

COMMUNICATE

In order to promote the sector, a directory of ALLICE member companies is widely distributed. Each member of the Club undertakes to complete the information concerning their company and to obtain the agreement for their distribution. Each member also undertakes to publicise and promote ALLICE and its activities whenever possible (websites, social media, publications, trade fairs, conferences, etc.) and to cite ALLICE in all cases when using the results produced collectively in its communication operations.

SUPPORT EACH OTHER

Club PRIME is a community of practice that allows members to develop their professional network. In order for the sharing of experiences to be sustainable, they must be able to exchange with each other outside the Club's formal activities. Each member therefore agrees to be contacted and, conversely, to use the contact information distributed only for their own needs or to initiate cooperation. Under no circumstances may this information be used for commercial prospecting.

In addition, ALLICE promotes and supports cooperation among its members, and expects in return to be informed of any partnership that could arise within the framework of its activities.

FACILITATE THE ORGANIZATION

Each member must confirm their participation and that of their colleagues or representatives in a Club activity at least one week before the date. In the event of cancellation or delay, members must inform the Club as soon as possible. If a member is unable to attend, they must request a replacement from the organization. The member agrees that the person accompanying them or representing them will respect the Club's criteria of confidentiality and responsibility.

PAY ITS DUES

The proper functioning of ALLICE requires regular payment of dues by members. Club PRIME members are responsible for ensuring that their company complies with the membership terms and payment deadlines as defined in ALLICE's internal regulations.
